

NOTICE OF DÁIL ELECTION

CONSTITUENCY OF MAYO

Pursuant to a writ issued to me by the Clerk of Dáil Éireann I am about to proceed to the election of FOUR member(s) of the Dáil for this constituency.

Nomination papers may be obtained from the address below during the usual office hours.

A person may nominate himself/herself as a candidate or may, with his/her consent, be nominated by a proposer who is registered as a Dáil elector in the constituency.

A nomination paper from a candidate of a registered political party must have a certificate of political affiliation attached which must be produced to me with his/her completed nomination paper.

If no certificate is attached, the candidate must, before the latest time for receiving nominations, either-

- secure 30 assents to the nomination by way of statutory declarations by Dáil electors registered in the constituency (forms available from me or the registration authority), or
- make a deposit of €500 (deposit may also be made on the candidate's behalf).


Details of these requirements are set out in the Electoral (Amendment) Act 2007.

The latest time for receiving nominations is 12noon on the 22nd day of January, 2020.

Completed nomination papers may be delivered to me in person by the candidate or his/her proposer at any time when I am at my office, from 10am on the 18th day of January, 2020 until 12 noon on the last day for receiving nominations, by prior appointment.

I am required by law to attend to receive nominations between 10am and 12 noon and between 2pm and 5pm on the 21st day of January, 2020 and between 10am and 12 noon on the 22nd day of January, 2020.

If the election is contested, a poll will be taken on the 8th day of February, 2020 between the hours of 7am and 10pm.

- 30 aontú a bheith faighte aige nó aici le haghaidh an ainmniúcháin trí dhearbhuíthe reachtúla ó thoghthóirí Dála a bheidh cláraithe sa dáilcheantar (tá foirmeacha le fáil uaimse nó ón údarás clárúcháin), nó
- €500 d'earlais a leagan síos (is féidir earlais a leagan síos ar son iarrthóra chomh maith).


Tá na sonraí faoi na riachtanais seo leagtha amach san Acht Toghcháin (Leasú) 2007.

Is é an t-am is déanaí chun ainmniúcháin a ghlacadh isteach an 12 a chlog meán lae an 22 lá de Eanáir, 2020.

Féadfaidh an t-iarrthóir nó a thairgeoir páipéir ainmniúcháin agus iad comhlánaithe a sheachadadh domsa go pearsanta aon tráth a mbeidh mé i m'oifig, ó 10 a chlog ar maidin an 18 lá de Eanáir, 2020 go dtí 12 a chlog meán lae ar an lá deiridh chun ainmniúcháin a ghlacadh, tri chonire roimh ré.

Éilítear orm de réir dlí a bheith i láthair chun ainmniúcháin a ghlacadh idir 10 a chlog ar maidin agus 12 a chlog meán lae agus idir 2 a chlog agus 5 a chlog sa tráthnóna an 21lá de Eanáir, 2020 agus idir 10 a chlog ar maidin agus 12 a chlog sa tráthnóna an 22 lá de Eanáir, 2020.

Má théitear in iomaíocht sa toghchán, beidh vótaíocht ann an 8 lá de Feabhra, 2020 idir 7 a chlog ar maidin agus 10 a chlog sa tráthnóna.
